




To Consider;

What can our Recreation Facilities be in 2040

1. What is our vision for our (all) Facilities in 2040?
2. Have we considered all the options to us?
3. We have been given an opportunity to create a vision for Paola Recreation?
4. We have been given the trust of all of our citizens with the award of the 2020 Sales tax levy.
 - a. This is a 12 Million dollar award that we are now the stewards of.
 - i. Citizens have entrusted us to do the following
 1. Have a clear and concise plan for the appropriation of the funds.
 2. Spread the dollars out in a reasonable split to take care of multiple public infrastructure issues.
 - a. Lake Miola Dam stabilization
 - b. Recreation facilities
 - c. Street
 - d. Storm water improvements
 - e. Water and Sewer Infrastructure and improvements
 - f. Facilities and improvements to our existing buildings
 - g. Possible acquisition of new land and facilities to meet the goals of the items mentioned above
 6. These are all things that need to be considered and put into the total scope of projects and improvements that the public has charged us with as stewards of the 2020 Sales Tax Levy

 - Annual budget to maintain?
 - Annual budget for heavy maintenance replacement?
- If we have a vision and plan, but do not document it, how can we transfer it to the next round of citizens that sit in these seats as stewards of the city to know what we had in mind?

If it is not comprehensive and complete...

- From concept
- To completion
- To maintenance
- We will have failed in the trust and obligation that the citizens have bestowed on us.
- Has the future of the Paola Recreation Commission been included in the recent comprehensive plan?
- Has the future of the Paola Parks been put into the Comprehensive Plan?
- Will future developments require planning and dedicated parkland?
- Have any future plans for Lake Miola been discussed? Is there a vision?

Things to Consider;

- Do we have a vision?
- What are our goals?
- Is the long term plan written down?
- Why don't we have a long term plan?
 - It may be whimsical.
 - It may be unattainable.
 - How do we know?
 - Have we invited others into help us with a vision?

Options to consider

Options to consider-

- Bernard Community Park Lansing, Kansas
- This project bid earlier this month.
- Total cost- 4.2 Million Dollars
- Lets review what it purchased
 - Green field site (City already owns the ground)
 - See attached sheet
- For the sake of transparency, I have no relationship with any of the engineers or architects.

Have we looked at purchasing a green field site?

Cost of the project would need to be established

- Ground cost deducted from the budget
- Construction would be commensurate with the available balance
- Future growth of all activities would be laid out and planned for

Legacy Property owners

- For clarification I have not talked to any of the possible owners.
 - I do not have that authority
 - I can look at what may be possible
 - Ask the questions on the Council to consider
- I am using the term Legacy Property owner, as a property owner that has lived or owned the property for a long time. Are existing citizens of the Paola and Miami County community
 - Have they been approached with a true “Concept Plan and Vision” of how the property may be used?
 - Have we seriously approached them?
 - I don’t know if these Legacy Owners would be willing to sell their land to the City Parks program.
 - As a city we need to help them understand the vision of the Paola Parks program.
 - I do know that once the property changes hands the price will be 125% of what the new owner paid for it
 - So any opportunity to purchase at any price will be higher


Site evaluation

- Employ the services of a Landscape engineer to put some preliminary sketches together of the sites of interest for discussion by the council, and to provide our vision and long term goals to the property owners.
 - This engineer should be
 - Independent of any of the previous discussions regarding facilities
 - Landscape Architect or Engineer with multiple projects in his/ her resume.
 - Projects that have been constructed and in service
 - Solicit someone to negotiate with the land owners
 - Preferably at a very low fee or Pro Bono

In Conclusion

We need to be cognizant of what the future needs will be with the new Paola Recreation Commission and the Paola Parks Program.

- Facilities required
- Other management assistance and coordination
- Future line item budget for maintenance and acquisitions
- We are the stewards of the 2020 Sales Tax Levy and should work to spend these dollars over all the projects that need attention and were listed on the Sales Tax issue.
- Our schedule of importance of the improvements should be based on what is best for the entire Paola Community.
 - Maintenance
 - Improvements
 - Acquisitions.
- We must not be hasty with the decisions to follow through with the wants and needs of our community


