All work requiring a permit shall be suspended upon the expiration of a permit.

DEMOLITION CHECKLIST

Follows are items that will be part of the City's inspections.

- Cap sewer line outside of structure before beginning demolition. Call 913-259-3611 for inspection.
- Any excavations / holes shall be fenced appropriately for the duration of the demolition.
- Remove all floors, foundations, footing, basement and retaining walls down to 18 inches below grade.
- Demolition debris must be removed from the site and delivered to a licensed landfill or recycling facility.
- Fill excavations and other cavities with clean fill material. Call for a pre-backfill inspection first!
- All permanent site stabilization, erosion and drainage controls must be in place before final approval is granted.
- Restore site as indicated on permit. Call for a final inspection.
